The name "Tribology", denoting friction, lubrication and wear related studies, was coined by Prof. H. Peter Jost in 1966. Tribology Society of India (TSI) is a premier professional society set up with a vision to spread awareness and practice of Tribology all across India. To fulfil this mission, the Society has been organising International Conferences on Industrial Tribology (ICIT) biennially in different parts of the country, to enable the practitioners of Tribology to discuss and showcase their work in various aspects of this multidisciplinary area. The 8th International Conference on Industrial Tribology (ICIT-2012) is being organized by leading industries from the Public and Private Sector in India, under the aegis of TSI. The event will be held during 7 - 9 December 2012 in the Western part of India, at the beautiful city of Pune.
